REMINISCING ONE YEAR BACK!

Raya is upon us again and I was looking at the speech that I prepared for Raya last year, which was almost immediately after the elections and it was a speech of cautious optimism during a time of major change. At that time, the cabinet ministers were still not appointed, the KSUs of all the ministries were being changed and all the major organisations like Bank Negara, DBKL, MACC, Police, Bursa were having new heads appointed. It was also the first time that there was no more GST and SST so everyone could enjoy and buy things tax-free for 3 months. We also learnt a new number, 1 trillion, or a 1 followed by 12 zeros or 1,000 billion, which was the national debt! It was a traumatic time of change and everyone expected a period of 6 to 9 months to settle.

Today, 1 year or 12 months later, things are more settled, we have a full cabinet, the debt is being addressed, ministry KSUs are in place, BUT the key factor for LLC Group, which is government spending is still slow, and projects are few and rare! I recently met up with one of our clients and they say that this is probably the worst time they have faced in their 30 years career. My talks with our partners, suppliers and subcontractors also indicate extremely challenging times where tenders are so few and rare that submissions are sometimes only 50% to 60% of the project tender budget! These are still extremely challenging times, but I would like to remind everyone that it is during these tough times that we need to be more resilient and the true measure of any person is that they need to get up when they fall down, and continue to run!

We need to count our blessings as LLC Group continues to run with strong cash balances of RM80m, our order books have been replenished during these difficult times and currently stands at over RM800m. Our 14MW Kerian Mini Hydro concession has just achieved Commercial Operation Date status, which means that we can now bill TNB and get in some money! Panorama, our Kelana Jaya development has almost reached our target of 60% sales for this year and almost all our operation staff and equipment is now deployed to project sites. We have also just been certified with ISO45001 and ISO14001 for environmental and safety systems; special thanks goes to Mahmud, Zikri, Ms Thum and Heng who had worked hard on it. These new ISO certifications put us on par with international groups and will improve our branding and assist us with our tenders.

LLC Group is indeed blessed to be better off than most of our competitors, but times are challenging and project margins are lower with less projects and increased competition, so we need to continue to be more efficient, more productive and more innovative to get past this period! Let's be grateful for what we have, and all pray that the government will continue with infrastructure development for better times. There is some glimpse of hope with the revival of ECRL and Bandar Malaysia so hopefully the momentum continues.
